This MOU is entered into the 12th day of Telmany 2020 by and between Department of Physics, Sacred Heart College situated at Tirupattur, Vellore and Department of Physics, Annai Velankanni College situated at Tholayavattam, Kanyakumari District, Tamilnadu.

## Objective of the MOU

This Memorandum of Understanding sets for the terms and understanding between the
Department of Physics, Sacred Heart College, Tirupattur, Tamilnadu (SHC) and
Department of Physics, Annai Velankanni College, Tholayavattam, Kanyakumari
District (AVC) to create student quest for knowledge in Physics, their capacity to think
critically and their ability to put ideas across effectively to do quality teaching and
research.

### 2. Technical Area of collaboration

- a) Joint research activities including the participation in projects.
- b) Provide academic interaction by delivering special lectures at SHC and AVC on topics of relevance to modern society.
- Exchange of scientific and technological information and joint publications of common results.
- d) Organize summer training programs for final year students of SHC at AVC and vice versa.
- e) Facilitate the hands on training for PG students and research Scholars.
- f) Exchange of students between the departments





Both the departments recognize each other's legal capacity to sign this agreement and

#### DECLARE THAT:

Sacred Heart College and Annai Velankanni College manifest their intention to reach an agreement to foster academic cooperation according to the following terms and conditions:

**ARTICLE 1.** Both the departments agree to promote joint teaching, research and other academic activities as aforesaid in the objectives and technical area of collaboration for mutual benefit.

**ARTICLE 2.** This agreement will be effective for a period of five years from the date of its signing and the renovation will be requested for the next period unless otherwise specified by the signing departmens.

ARTICLE 3. This agreement does not imply any financial duty upon both the departments.

**ARTICLE 4.** Either party may terminate this agreement on written notification. Such notification must be given at least six months prior to the proposed date of termination. If the present agreement is terminated, both parties must guarantee to facilitate the completion of the projects and initiatives already in progress.

### ARTICLE 5.

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case basis and will be consistent with officially laid down IPR polices of the two institutes.
